### FASTER TAX REFUNDS WITH DIRECT DEPOSIT 2016 DATES TO REMEMBER

January 1, 2016 - First day to contribute money to our Traditional and/or Roth IRAs for 2016! The maximum contribution limit is now \$5,500.

**April 1, 2016** - Last day for 2016 that you may choose to receive your first Required Minimum Distribution. For Traditional IRA owners who reached age 70-1/2 during 2016.

April 15, 2016 - Last day to open or contribute money to your Traditional and/or Roth IRAs for 2016. - Federal Income tax Filing Deadline.

**September 30, 2016** - Last day to establish a separate account for the death benefits of an IRA if the owner passed away in 2016. Beneficiaries can be removed either by valid disclaimer or by receiving a full distribution of their inherited funds, but cannot be added.

**December 31, 2016** - Last day to convert from a Traditional IRA to a Roth IRA for 2016. - Last day for 2016 to received a Required Minimum Distribution for your Traditional IRA. For IRA owners who have reached age 70-1/2 or older. - Last Day for 2016 for death beneficiaries of a decease owners IRA to receive a Required Minimum Distribution.

If you expect a refund when you file your federal taxes, the IRS makes it easy for you to directly deposit the funds into your Stanwood Area FCU checking or savings account. According to the IRS, you'll get your refund up to 3 weeks earlier than by mail. Its safe (can't be lost or stolen), easier, and you get to use the money faster.
