### OVERDRAFT PRIVILEGE PROGRA

Overdraft Privilege is a non-contractual service provided by the credit union designed to help members who occasionally overdraw their checking accounts. By paying items up to the established limit, the credit union can protect members from additional costs associated with returned items, such as merchant fees and late fees. As long as the member maintains their account in good standing, the credit union may continue to extend the overdraft privilege limit; however, the credit union is not obligated to pay any items.

Cards are not directly linked to savings or share draft accounts, however funds are loaded from your credit union accounts.
